Fire Department News

until October 15, 2018.

Chimney Cleaning Two chimney fires both happened within
fifteen hours the same day in February and were a strong reminder of
how important proper and regular cleaning of your chimney is.
The British Columbia Fire Code requires that chimneys, flues or flue
pipes shall be cleaned as often as necessary to keep them free from
dangerous accumulations of combustible deposits.

Emergency Operations Funding The District has received a
\$25,000 grant to outfit an emergency operations centre and to
participate in training opportunities. The District will outfit a mobile
unit which may be used at multiple locations depending on the
situation. The intent of this mobile EOC solution is to create a
stockpile of pre-packed ready to go supplies that would only be used
to operate an EOC, and would contain every supply needed to
operate that EOC (paper, pens, printers, phones, staples, files, maps,
whiteboards, etc.).

Federal Cannabis Act In anticipation of the legalization of recreational cannabis,
the District is considering a zoning bylaw amendment that would prohibit throughout the District:

1. Cannabis production
2. Cannabis sales, and
3. Commercial-type medical cannabis production

This action is consistent with past District decisions in regards to federally controlled commercial medical cannabis production and sales.
The purpose of the proposed bylaw is to be as restrictive as possible at least initially until Provincial legislation is passed. Once that
happens, there may be an interest in community discussions about recreational cannabis that may or may not lead to changes from this
initial approach. **The public hearing will be held Monday, June 4, 2018 at 7pm at the School House.**

It is important to note that the proposed bylaw does not prohibit medical cannabis production in the cases of individuals and designated
persons who are registered with the federal government with respect to medical cannabis.

The CRD amended its Clean Air Bylaw to include any substance vaped or smoked, thus restricting consumption of cannabis from public
areas of the CRD. This includes all typical public indoor areas (business, schools, etc.), patios where food and beverages are served or
consumed, parks, playgrounds, beaches, public squares, and bus stops. This link provides detailed information:

We urge you to read the informative *tax insert* which will accompany the *tax notice* which will highlight the latest budgetary information.

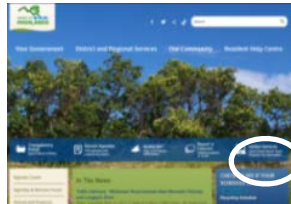
Home Owner Grants (HOG) must be claimed every year

Banks no longer accept Home Owner Grant applications, therefore, the District of Highlands provides **online** options. We also accept HOG applications at our counter, secure drop box or by mail. Please remember to claim every year.

Visit the District's website www.highlands.ca and click the **Online Services** button.

You will find the following options and instructions:

- **Claiming Your e-HOG** via the District's website.
- **Viewing Your Tax Account** - you must register to safeguard your personal information.
- **Paying Your Taxes** - information on how to pay through your Financial Institution's website.
- **Pre-authorized Payment Plan** - Program runs August 10 to May 10.
- **Viewing Property Information For The Public.**

Open House – Secondary Suites and Accessory Dwelling Units

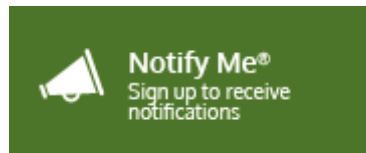
As part of Council's Strategic Plan, Council asked staff to prepare a report outlining an approach to considering secondary suites in the community. While secondary suites are not permitted under existing zoning regulations, it is estimated that approximately 30% to 50% of properties in Highlands have some form of unauthorized secondary suite and/or additional unapproved dwellings. Given increasing land costs and housing shortages in the region this trend is likely to continue.

Staff have reported to Council twice on the issues. The first report was submitted for Council consideration in December, 2017. Council received the report and asked that staff bring back additional information. A second report was submitted to Council for consideration in April, 2018 and Council received the report and directed staff to proceed with an open house to solicit input on the proposed draft policy/program and regulatory framework.

Council invites all residents to attend the Open House to discuss secondary suites and accessory dwelling units on Wednesday, June 6. Input from the open house will be forwarded to Council to assist in considering policy setting regarding secondary suites and accessory dwellings.

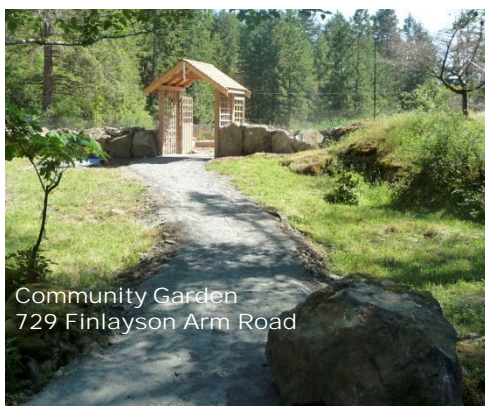
Slow Down and Drive Safely

Allotment beds are now available for rent at \$25 (half price this year). Garden beds are 10' x 4' and are available on a first come first served basis.

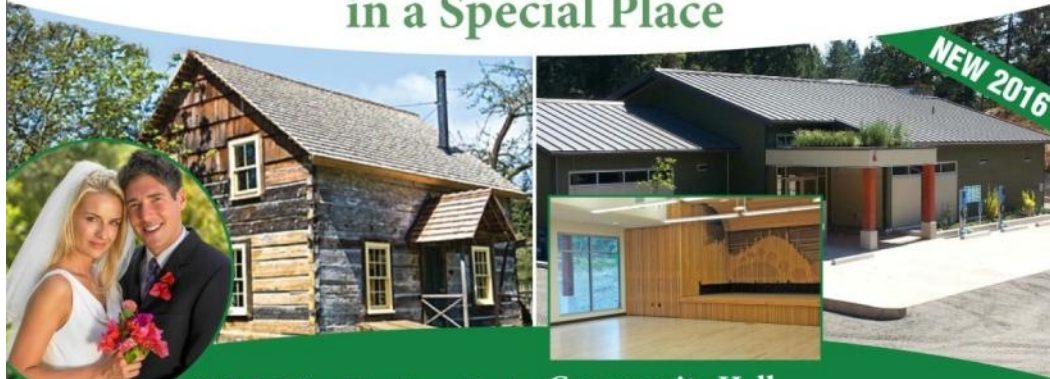
